ORDER

In accordance with the directions contained in the Government Order read as sixth paper above, the following orders are issued to all Managers of aided institutions coming under the General Education Department,:-

- (i) To ensure 3% reservation of the total number of vacancies in the cadre strength in appointments in aided schools to the posts which are identified as suitable for persons with disabilities and issued vide Government Orders read as 1st to 5th papers above, with effect from 07.02.1996 and to fill the backlog from 07.02.1996 to 18.04.2017 as per the provisions of Persons with Disabilities (Equal Opportunities, Protection of Rights and Full Participation) Act, 1995 with immediate effect.
- (ii) To provide 4% reservation of the total number of vacancies in the cadre strength in appointments in aided schools to the posts which are identified/to be identified as suitable for persons with disabilities with

effect from 19.04.2017 as per the provisions of Rights of Persons with Disabilities Act, 2016.

- 2. It is also ordered that immediate steps should be taken to calculate backlog of vacancies in schools and to fill up the same in the arising vacancies.
- 3. The Director of General Education shall ensure implementation of the above directions as well as reservation as prescribed in the Government Order read as 6th paper above in regard to identification, selection and appointment in all aided institutions is strictly followed.
